

# Burohelp SDG & ESG Donation Terms and Conditions

For Donation-Receiving Public Benefit Organisations (PBOs) Across Europe

## 1. Purpose of These Terms

These Terms and Conditions define the responsibilities, commitments and compliance obligations for Public Benefit Organisations ("PBOs") within Europe that receive financial contributions, operational support, or SDG/ESG-related benefits through **Stichting Burohelp** ("Burohelp").

Their purpose is to ensure:

- Transparent, ethical and SDG-aligned use of donated funds
- Uniformed governance and proper oversight across EU jurisdictions
- Credible ESG insights for reporting by donors
- Protection of Burohelp's integrity, mission, and Time Bank system
- Fair and responsible distribution of support to verified PBOs

These Terms apply to all PBOs / ANBIs onboarded on the Burohelp Platform across the European Union, EEA, and associated European territories.

## 2. Eligibility Requirements

To receive donations or support through Burohelp, an organisation must:

- 1. Be officially registered as a PBO, ANBI, charity, foundation, or equivalent public benefit entity in its country of operation.
- 2. Maintain its public benefit status at all times.
- 3. Operate in alignment with at least one UN Sustainable Development Goal (SDG).
- 4. Have a verifiable record of ongoing environmental, social, humanitarian, cultural or community-based activities.
- 5. Agree to follow all Time Bank logging requirements (projects → activities → hours).
- 6. Demonstrate transparent governance and financial stewardship.
- 7. Operate legally within all EU/local regulatory frameworks.

If any eligibility requirement is no longer met, Burohelp may suspend or terminate participation.



## 3. Transparency & Time Bank Requirements

To ensure transparent and measurable impact, each participating PBO must:

- Create and maintain **Project** entries for all initiatives receiving or related to Burohelp support.
- Create **Activities** within each Project describing the tasks carried out.
- Log **Actual Hours** (volunteers, staff, specialists, external experts).
- Provide documented proof when requested (before/after evidence, photos, reports, notes).
- Ensure that all logged hours are truthful, accurate and linked to real operational work.
- Notify Burohelp promptly about corrections, misreporting or irregularities.

Burohelp reserves the right to conduct random audits of recorded activities.

## 4. Proper Use of Donated Funds

All donations received via Burohelp must be used **exclusively** for:

- The approved project(s)
- · SDG-aligned activities contributing to public benefit
- Operational expenses necessary to execute the supported activities
- Community-benefiting costs related to environmental, social or humanitarian work

#### Funds may not be used for:

- Private benefit
- Excessive administrative salaries
- Political campaigning
- Religious proselytizing
- Commercial business development
- Activities unrelated to registered PBO/ANBI work

Improper use of funds may result in repayment obligations and removal from the Burohelp platform.

### 5. ESG & SDG Impact Documentation

To support donor ESG and CSRD reporting obligations, PBOs must:

- Maintain project documentation on outcomes
- Provide honest descriptions of environmental or social results
- Indicate which SDGs are addressed
- Respond to reasonable requests for clarification
- Allow Burohelp to summarize impact information for donors



PBOs remain fully responsible for the accuracy of their own reporting.

## 6. Compliance With EU Legal & Ethical Standards

PBOs must comply with:

- EU anti-corruption and anti-fraud regulations
- GDPR / data protection rules
- EU sanctions and anti-money-laundering legislation
- National laws and regulations relevant to their activities

Any breach may result in termination of the collaboration.

#### 7. No Influence From Donors

Burohelp protects the independence and mission of all participating PBOs.

#### Donors have no authority to:

- Direct or control the organisation
- Interfere with governance
- Influence political or religious decisions
- Determine beneficiaries or internal priorities

Support is provided based on logged need and validated activity and not on donor preference.

## 8. Communication, Images & Visibility

PBOs may share authentic stories, visuals and results related to supported activities, provided that:

- Publications are truthful and respectful
- No false association is created between Burohelp and unrelated work
- Donor names are only used when consent has been given
- Sensitive beneficiary data is protected (GDPR)

Burohelp may also share PBO impact stories unless the PBO requests otherwise.



## 9. Audit Rights

To maintain the credibility of the Time Bank:

- Burohelp may request documentation or evidence
- Burohelp may review project logs
- External auditors may perform checks if required by donors or regulators

Failure to cooperate with audits may lead to suspension.

## 10. Termination of Participation

Burohelp may suspend or remove a PBO if:

- Eligibility requirements are no longer met
- · Misuse of funds is detected
- Fraud or misrepresentation occurs
- Hours or projects are systematically misreported
- The PBO violates legal or ethical obligations
- The PBO endangers the reputation or integrity of Burohelp

Terminated PBOs must return unused designated funds.

## 11. Liability

Burohelp is not responsible for:

- Operational risks of PBOs
- Outcomes of PBO projects
- Misuse of funds by PBOs
- Legal claims resulting from PBO activities
- Loss of funding due to regulatory changes

PBOs remain independently liable for their own actions.

## 12. Applicable Law

These Terms and Conditions are governed by:

- The laws of the **Netherlands**, where Stichting Burohelp is legally registered
- Complementary EU legislation regarding charitable activities, data protection, anti-fraud and financial transparency

Any disputes will be handled in accordance with Dutch civil law.
